Series B, F and O units of Fidelity Advantage Ether ETF Fund™

(the “Funds”)



The Simplified Prospectus is being amended to:

- 1) provide notice to investors that portfolio managers, Matthew Siddle and Helen Powell, will be stepping away from portfolio management responsibilities of Fidelity Europe Fund. Matthew Siddle will transition off Fidelity Europe Fund on or around September 30, 2024 while Helen Powell will come off Fidelity Europe Fund on or about July 31, 2024. Effective September 1, 2024, portfolio managers, Sam Morse and Aruna Karunathilake, will assume portfolio management responsibilities for Fidelity Europe Fund; and
- 2) reduce the management fees of Fidelity Advantage Ether ETF Fund™, effective July 23, 2024.

All capitalized terms used but not defined in this Amendment No. 7 have the respective meanings set out in the Simplified Prospectus.

AMENDMENTS TO THE SIMPLIFIED PROSPECTUS

The technical amendments to the Simplified Prospectus required to effect these amendments are set out below.

Part A

1. Responsibility for administration of the Funds
