The Simplified Prospectus is being amended to inform investors that:

1. the portfolio manager of Fidelity Women’s Leadership Fund, Nicole Connolly, will be retiring on December 31, 2024. Also, effective December 16, 2024, Preeti Sayana has been appointed as a portfolio manager to work alongside Nicole until her retirement and will take over portfolio management responsibilities thereafter; and
2. effective December 31, 2024, co-portfolio managers of Fidelity Long-Term Leaders Fund, Camille Carlstrom, Charles Hebard, William Shanley, Tim Codrington and Risteard Hogan will be replaced by portfolio manager, Kwasi Dadzie-Yeboah, to co-manage this Fund alongside remaining portfolio manager, Michael Kim. This Fund is the underlying fund to Fidelity Long-Term Leaders Currency Neutral Fund.
