### Policy overview

FIC has established a policy which seeks to protect and preserve investors' capital in Tax-Smart CashFlow while supporting investors' monthly cash flow needs.

### Annual rate reset

Monthly payout rates are set at the beginning of each year, so investors will know how much they will receive each month.

Immediately following the December 31 valuation date of any year, the cash flow per unit of each series of each Fund will be reset to 5% or 8% of the net asset value as of December 31 of the previous calendar year divided by 12 to produce the monthly payout.

This new target annualized cash flow rate will be effective as of January 31<sup>st</sup> and remain the same each month for the rest of calendar year.
