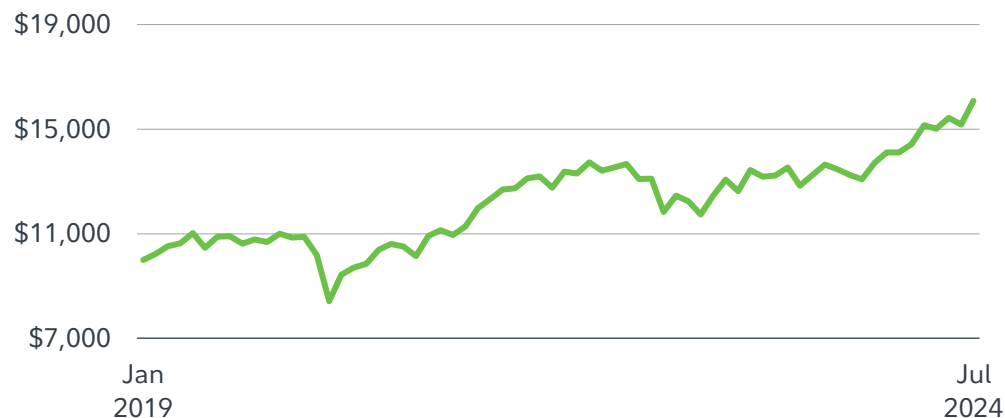
## Why invest in this ETF?

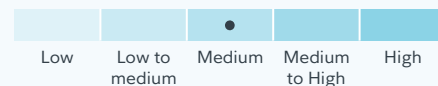

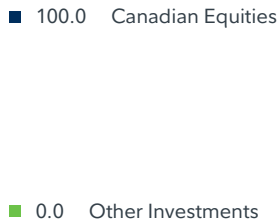
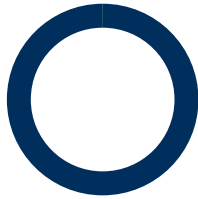

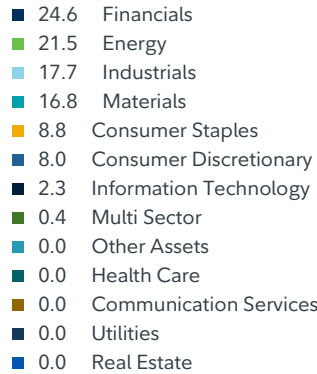
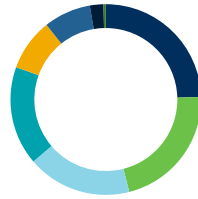
