

The estimated trailing 12 month yield is intended to show a fund's distributions in percentage form relative to its NAV. The calculation typically excludes capital gains, return of capital and yearend tax adjustments, and currently applies to funds that pay monthly distributions (i.e. income-generating funds). The calculation takes the sum of a fund's last 12 months' distributions and divides that number by the fund's average NAV over the last 12 months one business day prior to the ex-dividend date for Mutual Funds and ETFs.
