This document contains key information you should know about Fidelity Founders Currency Neutral Class™ - Series A (the "Fund"). Before you invest in any fund, you should consider how it would work with your other investments and your tolerance for risk.

Effective May 6, 2024, the Fund's risk rating will change from "medium" to "medium to high". The Fund's risk rating in the "Risk Rating" section below has been updated to reflect the new risk rating of "medium to high" effective as of May 6, 2024. The Fund's current risk rating of "medium" will continue to apply until May 6, 2024.

Effective June 1, 2022, the Deferred Sales Charge, Low Load Sales Charge and Low Load 2 Sales Charge options will no longer be available for purchase. If you bought shares of the Fund under one of these options before June 1, 2022, your deferred sales charge schedule will continue to apply as described in this document.

WHAT DOES THE FUND INVEST IN?

The Fund invests in Fidelity Founders Investment Trust™ (the underlying fund), which aims to achieve long-term capital growth by investing primarily in equity securities of companies anywhere in the world, with an emphasis on U.S. equity securities. The underlying fund seeks to identify investment opportunities in equity securities of founder-involved companies. The Fund uses derivatives to try to minimize the exposure to currency fluctuations between developed market foreign currencies and the Canadian dollar.

The charts below give you a snapshot of the underlying fund's investments on February 29, 2024. The underlying fund's investments will change.

■ HOW RISKY IS IT?

The value of the Fund can go down as well as up. You could lose money.

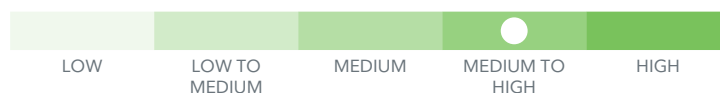
One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

RISK RATING

Fidelity has rated the volatility of this Fund as **medium to high**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

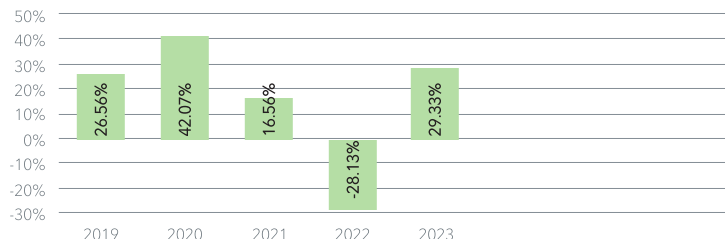
Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

■ HOW HAS THE FUND PERFORMED?

This section tells you how Series A shares of the Fund have performed over the past 5 years. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

YEAR-BY-YEAR RETURNS

This chart shows how Series A shares of the Fund performed in each of the past 5 years. The Fund dropped in value in 1 of the 5 years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



BEST AND WORST 3-MONTH RETURNS

This table shows the best and worst returns for Series A shares of the Fund in a 3-month period over the past 5 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

AVERAGE RETURN

A person who invested \$1,000 in Series A shares of the Fund on the inception date now has \$1,944. This works out to an annual compound return of 12.0%.

■ WHO IS THIS FUND FOR?

Investors who:

- plan to hold their investment for the medium- to long-term
- want to gain global equity exposure with an emphasis on U.S. equity securities while seeking to lower their risk of currency fluctuations between developed market foreign currencies and the Canadian dollar
- can handle the volatility of returns generally associated with equity investments

The Fund is not an appropriate investment if you have a short-term investment horizon.

Registered plan investors should be aware that the Fund may, from time to time, bear an income tax expense which will reduce returns.

■ A WORD ABOUT TAX

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan (RRSP) or a Tax-Free Savings Account (TFSA).

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

■ HOW MUCH DOES IT COST?

The following tables show the fees and expenses you could pay to buy, own and sell Series A shares of the Fund. The fees and expenses - including any commissions - can vary among the series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1 SALES CHARGES

You have to choose a sales charge option when you buy Series A shares of the Fund. Ask about the pros and cons of each option.

For all the sales charge options

- There is no charge when you buy shares of the Fund.
- The charge is a set rate paid to Fidelity and is deducted from the amount you sell.
- The schedule is based on the original cost of your shares.
- Fidelity does not charge you to switch to other Fidelity Funds of the same series.

2 FUND EXPENSES

You don't pay these expenses directly. They affect you because they reduce the return you get on your investment.

As of November 30, 2023, the Fund's expenses were 2.59% of its value. This equals \$25.90 for every \$1,000 invested.

Upon the automatic switch of your series A shares into series B shares, you (a) will have a lower management fee of 1.85%; and (b) may qualify for lower combined management and administration fees paid as fee rebates as part of the Fidelity Preferred Program (the "Program"). ■ HOW MUCH DOES IT COST? (CONTINUED)

More about the trailing commission

The trailing commission is an ongoing commission. Fidelity pays a trailing commission to all dealers, including discount brokers, for as long as you own the Fund. This is for services and advice that your representative and their firm provide to you. When these commissions are paid to discount brokers, they are for services and any tools or other assistance that your discount broker may offer.

The trailing commission is paid from the Fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.

Upon the automatic switch of your series A shares into series B shares, your representative may receive a trailing commission of up to 1.00% of the value of your investment each year.

■ OTHER FEES

You may have to pay other fees when you buy, hold, sell or switch shares of the Fund.

FEE	WHAT YOU PAY
Short-term trading fee	If you sell/switch shares within 30 days of the oldest purchase/switch into the Fund, you <i>will</i> be charged 1% of the value of those shares. If you sell/switch shares within 30 days of the most recent purchase/switch into the Fund, you <i>may</i> be charged 1% of the value of those shares or have your account restricted/closed. This fee goes to the Fund.
Switch fee	Your representative's firm may charge you up to 2% of the value of shares you switch to another series of the Fund or another Fidelity Fund. However, you will not pay a switch fee on Fidelity initiated automatic switches.
Fee for sizable redemptions	If you have been notified that you own a sizable percentage of a Fund, you <i>will</i> be subject to a 1% penalty of the value of the shares that you sell/switch if you sell/switch your shares of the Fund within 30 days of your most recent purchase/switch into the Fund. You <i>may</i> be subject to a 1% penalty of the value of the shares if you fail to provide the required notice to Fidelity prior to completing a sizable redemption. This fee goes to the Fund.

■ WHAT IF I CHANGE MY MIND?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
